I read an article on the internet about the Chicago Water District going after current pensions of their retirees. The formula was declared improperly figured. Guess what, retiree pensions were reduced and were sent a bill for that retiree to pay back thousands of dollars. One received a bill for \$40,000 another \$60,000.00. Now this didn't happen in our state, however, we need to be aware of these gimmicks being done to other pension holders.

As a member on the Health Care Committee we are currently talking about our current vision and dental benefits. They haven't been changed for many years. Long Term Care is still an issue with the folks that bought in 1995.

Bylaws and Governing Rules Report

The CSR Board of Directors, at its November meeting, took the following actions to change the Governing Rules in:

- Section 1, ADMINISTRATION OF THE CORPORATION by removing superfluous language;
- Section 2, MEMBERSHIP AND DUES by clarifying and cleaning up language in this section;
- Section 4, DUTIES OF OFFICERS AND BOARD MEMBERS by reducing the amount of travel for the Board and consolidating the duty statement for the CFO from Section 11 to Section 4.04;
- Section 5, BOARD VACANCIES / ABSENCES by eliminating language that permitted "proxy voting" a violation of the Bylaws and Governing Rules;
- Section 7, DELEGATE ASSEMBLY by removing reference to CSEA Bylaws from CSR delegates Oath of Office;
- Section 8, MEETINGS by adding language to help secure meeting locations and ensure meeting minutes are sent out in a timely manner;

One way to reestablish our presence is to show our State elected officials that we continue to be a force that has a strong voice. I retired about ten years ago and I am a little more edgy about my retirement now than when I retired. Some of us have no other nest egg than our retirement and Social Security. If that is your situation you may need to reconsider your options.

FROM THE SIDELINES



It has been quite a while (over a year) since my last article for chapter 34. MEMBERS AND CHAPTER OFFICERS. This writer has had a go around, major some of it with infectious breakouts that seem unusual, but seem to be pandemic in our society these days.

If the retiree newsletter for November is handy, and it should be, folks......I will be touching on some of the articles/subjects that somehow relate to a lot of old –folksies, just coincidentally and personally.

On page one, Trinda the Editor of "Retiree" asks members: "Are you plugged into the internet, on line, and the like? If not why not??" I wrote her a short letter explaining that I do not because of "internet/on line fraudsters "who know how to work the system. See page 11 Jim Miller's column "Savvy Senior"—who lists over 13 scams seniors must watch out for, --internet and e-mail top the list.

On page four, Ted Toppin's "Legislative Watch" highlights 6 of the 800 Legislative Bills signed by Gov. Brown, which Ted tells us are endorsed by C.S.R. In my view five of the ones summarized are tiddly winx laws politicians' use to raise image on-the-cheap. I consider AB 707 (Ting,S.F.) of some worth to seniors, and "establishing senior slow signs" to remind speedsters that elders are walking around in the neighborhood should have been and could have been, accomplished by local governments—not in mine. So I do appreciate the effort on Mr. Tings part.

Future legislative attacks of State Pensions may be attempted in November 2014 elections. A San Jose mayor is planning to (at this date) challenge state/Us Constitutional protections awarded workers. Chuck Reed pushed his initiative city wide in San Diego, but it is being challenged in court currently. Members who live in San Jose should be peppering his mayor office with dissent messages. CSR's vested rights to benefits deserve member energy and due attention. (This article is on page 5)

On page nine, the top 20 costliest medical stays (and costs) is listed by the agency for healthcare research and quality (about time). Number 1 is something we are all –as human beings—subject to and yet most of us never heard the word....Septicemia which sucks up over \$20 Billion medical care dollars. Section 9, SERVICE AGREEMENT AND CORPORATE STAFF by adding the CFO during negotiations with CSEA and move Section 9.02 to Section 4.04, CHIEF FINANCIAL OFFICER / SECRETARY

Section 12, COMMITTEES by moving the Bylaws and Governing Rules Committee to Section 13.03;

Section 13, COMMITTEE ORGANIZATION AND RESPONSIBILITY by having all committees meet at the CSR Board of Directors meetings:

Section 16, CHAPTERS by having chapter Treasurers follow the CSR Treasurer's Handbook;

Section 14, CHAPTER GRANTS and Section 4.09, DUTIES OF OFFICERS AND BOARD MEMBERS by removing the Chapter Grants program from a committee and assigning it to the Board of Directors for efficiency and expediency. The language includes a new structure and funding expectations for chapters.
